1. CLIENT COMMITMENTS

- (a) I (the undersigned client) agree to forward the original copies of all correspondence from the credit bureaus including consumer credit reports and all other correspondence to this law firm.
- (b) I understand that it will only be necessary for me to purchase or otherwise obtain one set of individual credit reports.
- (c) I agree to inform this law firm of any change of address within (5) days of such a change. I understand that this law firm will be limited in its ability to provide services outlined in this agreement if I do not provide my current street address.
- (d) I agree to pay this law firm for work completed, on a monthly basis in an amount set forth in this agreement. I certify that I am not an employee or associate of any credit reporting agency nor am I retaining this law firm under any such false pretense.
- (e) You authorize us to discuss your case with your spouse.
- (f) I understand that the success of the service detailed herein depends heavily on the completion of my commitments.

4. FEES

- (e) The purchase of my credit report and FICO scores for me upon my request.

7. GENERAL PROVISIONS
